

The Board of Logan County Commissioners met in Regular Session with Commissioners Marvin Goodman present, Monty Pearcy present and Kody Ellis present and transacted following:

The agenda was posted at 1:31 P.M. on July 27, 2022 at the Courthouse, Courthouse Annex and LoganCountyOK.com.

1. Meeting called to order by the Chairman.
2. Flag Salute.
3. Open Public Hearing to consider the petition of Nicholas Scott Dean to annex the following described territory and lands situated in Logan County, Oklahoma, to-wit:

All of Sections 24, 25, 32, 33, 34, 35, and 36; all property located south of Cottonwood Creek in Section 13; the South Half of the Northeast Quarter of Section 26; the South Half of Section 27; and the East Half of Section 31, all in Township 15 North, Range 4 West of the Indian Meridian, Logan County, Oklahoma; and
All of Sections 19, 30, and 31; and all property south of Cottonwood Creek in Section 18, in Township 15 North, Range 3 West of the Indian Meridian, Logan County, Oklahoma, to the Deer Creek Fire Protection District pursuant to Title 19, Oklahoma Statutes, Section 901.22. Deer Creek Fire Protection District is a fire protection district duly organized and existing under the laws of the State of Oklahoma.

Chairman Goodman opened the Public Hearing at 7:01 PM. No one appeared to speak regarding the petition. The Public Hearing was closed at 7:05 PM.

4. Consideration of Order approving proposed annexation of territory in Logan County to Deer Creek Fire Protection District and calling an election of the qualified voters in the territory.

Assistant District Attorney Lowell Barto presented the Order approving the proposed annexation. He said that the notice must be published twice before the election in November. He stated that the County Clerk will provide Order and Notice to the Election Board Secretary to be placed on the ballot.

Monty Pearcy made the motion which was duly seconded by Kody Ellis with the voting as follows: Ellis-AYE, Goodman-AYE and Pearcy-AYE;

THAT, the Order calling for a special election to be held in Logan County, Oklahoma on November 8, 2022 for the purpose of submitting to the registered qualified electors in the territory proposed to be annexed the following proposition:

SHALL THE FOLLOWING DESCRIBED LANDS SITUATED IN LOGAN COUNTY, OKLAHOMA:

ALL OF SECTIONS 24, 25, 32, 33, 34, 35, AND 36; ALL PROPERTY LOCATED SOUTH OF COTTONWOOD CREEK IN SECTION 13; THE SOUTH HALF OF THE NORTHEAST QUARTER OF SECTION 26; THE SOUTH HALF OF SECTION 27; AND THE EAST HALF OF SECTION 31, ALL IN TOWNSHIP 15 NORTH, RANGE 4 WEST OF THE INDIAN MERIDIAN, LOGAN COUNTY, OKLAHOMA; AND

ALL OF SECTIONS 19, 30, AND 31; AND ALL PROPERTY SOUTH OF COTTONWOOD CREEK IN SECTION 18, IN TOWNSHIP 15 NORTH, RANGE 3 WEST OF THE INDIAN MERIDIAN, LOGAN COUNTY, OKLAHOMA,

BE ADDED TO AND INCLUDED IN THE DEER CREEK FIRE PROTECTION DISTRICT?
